2. The price and payment terms

3. The corporate contact data is entered into the text of the Agreement as the contact data of the Agreement Parties.

6. Upon signature this Agreement, the Corporate customer accepts the terms of Service Regulations of the Corporate customer network of KaR-Tel, LLP placed at the official site of the Operator www.beeline.kz, as well as gives its consent for receiving SMS and/or MMS by virtue of distribution of bulk messages, which is sent by KaR-Tel, LLP and/or its partners of informative, advertisement and entertainment character.
7. By signing this Agreement, a corporate customer joins to the terms of the Offer of Contract for provision of access to the Content (public offer), posted on the official website of the Operator at www.beeline.kz.
8. By signing this Agreement, the Corporate Customer agrees with the activation of the roaming service on the subscriber numbers specified in Table 1 of this Agreement. The corporate client confirms that it has been notified, acquainted and agrees with the inclusion of the roaming service in the Basic connection package with the Business Visa S package, if the Tariff Plan parameters do not provide other roaming charging conditions and the ability to change the Business Visa S roaming package by instructions in Table 1 of the Agreement (“Additional Services”), as well as the disconnection of the roaming service by submitting an application to the Operator or the corresponding indication in Table 1 of the Agreement.
9. By signing this Agreement, the Corporate customer agrees to disclose information to the Operator about itself and the terms of this Agreement to the Operator’s affiliated persons, including but not limited to employees, directors, contractors, service providers, software service providers and IT systems, VEON Ltd professional consultants (“Authorized representatives”). All issues not covered by this Agreement, the Parties shall be governed by the terms of the Operator’s Standard Contract, the Service Regulations of the Corporate customer network of KaR-Tel, LLP as well as an Offer of Contract for provision of access to the Content (public offer) and the legislation of the RK.
11. This Agreement, the Operator’s Standard Contract, the Service Regulations of the Corporate customer network of KaR-Tel, LLP and Offer of Contract for provision of access to the Content (public offer) are entire agreement by and between the Parties of this Agreement.
12. This Agreement enters into power upon its signature by the Parties and remains in force without limit of time, unless otherwise stipulated by this Agreement, the Service Regulations of the Corporate customer network of KaR-Tel, LLP and Operator’s Standard Contract.
